## TRAIL GUARDIAN INDEMNITY FORM

I acknowledge and understand that there may be risks associated with the patrol and monitoring project activities that I may be exposed to during the course of performing the patrol and monitoring activities. These may include proximity to individuals with criminal intentions or be associated with various kinds of infrastructure, bodies of water, animals, insects, trees and plants. I acknowledge and understand that I join the patrol and monitoring project at my own risk and shall not hold JCPZ, Jozi Trails and its partners liable for any incidents associated with such risks that occur during the course of executing patrol and monitoring activities;

I acknowledge that I may be exposed to communicable and other diseases and similar health hazards at a JCPZ facility and I undertake to take all and any appropriate measure to prevent any such incident from occurring during the course of patrolling and monitoring the affected JCPZ facility under this agreement;
4. I acknowledge that in the event that I am injured, fall ill or am exposed to any disease whilst present at any JCPZ facility during the performance of the Activities, JCPZ or Jozi Trails may at their sole discretion, without prejudice and/or admission of liability, arrange and pay for emergency medical treatment for and on behalf of the Volunteer, and that the Volunteer will be responsible to reimburse JCPZ in full for any such medical and related expenses.
